Dear Sarah,

Further to this meeting today I wish to confirm what it is I need to do in the three weeks you have given me.

If there is a specific point to be made during the text I have written I have attached a bullet point number to it to make sure that it stands out from the background text.

HATE

1. I wish to confirm that you have issue with the fact that, even though I do nothing wrong, people have this habit of turning against me without me doing anything to cause it

2. And that you have concerns that what is to stop it happening again

3. I am not sure why you have this concern as it suggests you believe that I am doing something to cause these events to happen

4. I would have thought that you have had enough experience of mental health to know that other people are more than happy to accept ones mental health issues, until it becomes inconvenient to them.

It greatly upsets me that you think I am doing anything to cause this, rather than do everything possible to return to the life that I lived for 40 years.

NOT INTENTIONAL HOMELESS

5. The only reason that I was placed into the Cedars Hotel was due to the Council speaking to my father and him telling them that he was making me homeless

6. However, today I was told that there is a "hidden rule" that owing to the time I was living there means that Suffolk Council will not regard that as being made homeless

WINCHESTER CITY COUNCIL

It needs to be recognised that Winchester City Council (WCC) at no time did anything to work with me. All they did was make decisions based on their own merits, irrespective of what anyone else said or did.

This is demonstrated by the number of times I attempted to report Discrimination or Hate by WCC and its employees, only for WCC to ignore every single attempt I made.

I also understand that being a person whom makes complaints labels me as difficult and as such means that Suffolk Council (SC) would be doing everything it can to show it has no Duty over me.

All I can say is that after spending five years living amongst people whom should have made complaint after complaint is that they didn't owing to this fear of being labelled difficult and not receiving help.

As someone who comes from a completely different background to all of these people, the only reason there is a need for me to make a complaint is owing to something being done incorrectly and seeking to make sure that this is addressed and no one else has to suffer from such issues.

It needs to be recognised that WCC did nothing, no matter what I said or did, to stop me living under the lie of being a Pedo.

7. I have been asked a number of times why I said somewhere that I lived with such a lie being told. I have always said, such is being on the Autistic Spectrum of Conditions (ASC)

8. Being on the ASC means that Routine and Stability matter more than anything else. It does not matter whether than Routine and Stability is good or bad, in the eyes of someone not on the ASC. I also stated that given the lies told about me where I currently was, I was scared about what lies would be attached to me if I moved somewhere else.

SUFFOLK COUNCIL

For all the time I was under the care of WCC I battled that a private rented property was correct for me. however, owing to WCC having a significant amount of Social Housing, thus basically free housing, they refused to accept their obligation that private was right and continued to insist that Social was right.

9. However, within the first few minutes of meeting with you and Jo, both of you said, without me saying anything, that Private Rental was the correct option for me. This should show that WCC was not prepared to accept me and my conditions / issues and treat me fairly.

TIMELINE

10.I need to provide a timeline from the day that I moved into Temporary Accommodation with Winchester City Council (WCC) to the time of the illegal eviction by WCC

11.This timeline is to show all the the events that happened

12.It is to included all documents I sent regarding the events, such events including but not limited to:

12.1.The night someone tried to kick my door in for over four hours

12.2.When I was a Male Victim of Domestic Abuse

12.3. When someone whom was a very close friend turned against me without any understanding why

12.4. When a new neighbour took great acceptance to me and started over a years worth of harassment

12.5.When other people continued to attack me, in and out of my home

12.6.When I was assaulted in the park and found out I was living under threat of life and didn't leave my home for over 6 months as I was scared of being killed

13.What it cannot include is any response to those documents

13.1.however, the fact that events where allowed to continue should demonstrate that Winchester City Council and the Police refused to do anything

14.It should also include any and all audio and video evidence I have regarding these issues

UNSUITABLE HOUSING EVIDENCE

15.I am to provide evidence that after telling WCC that the housing they thought suitable that they accepted those reasons by reason that they never told me they did not accept my reasons.

It is only because I thought those reasons, which where provided over a year before the illegal eviction, where accepted I did nothing other than contact Safeguarding seeking their help.

16.If I had known that WCC had not accepted that the housing was not suitable I would have done more to show them that it was

17.It needs to be noted that the first housing option I was offered was accepted as not being suitable. What is important is that there was only one housing officer who cared enough to help me. Jenny Cook was the only lady I spoke to in the Housing Department whom accepted events as they where.

18.She was the lady whom moved me into Temporary Accommodation (TA) based on the fact that where I was currently living was a Toxic Environment. After telling Jenny that TA was also a Toxic Environment she explained to me that those rules did not apply to TA.

When Jenny became aware of what was happening to me it took her six months to get over it and start talking to me again. I believe that this is because she blamed herself, even though she could not have known it, for placing me in TA.

19. When Jenny and I met to sort out moving out from TA into a permanent property she checked the stock that was on offer. Jenny expressed disbelief that just at the time I had gone to see her that the "best" property available from all of the stock that WCC had to offer was free

20. Jenny also said that just because it was the best didn't mean it was right. I agreed to visit the property. After seeing the property and explaining that it was not right Jenny accepted these reasons.

21. This, on its own, demonstrates that anything else offered by WCC was not suitable for me. It also needs to be noted that all of this happened before I was assaulted in the park and found out that there was a group of people actively searching for me owing to the fact that my neighbour hated me enough to spend a year telling everyone he met whilst walking his dog that the Council had moved a Pedo next door, but one, to him.

SECOND OFFER OF HOUSING

22. I took a video of the second house offered by WCC. This was to show why this property was unsuitable for me being on the Autistic Spectrum of Conditions (ASC) as well as having a PTSD

23. At this time it was not known that I was living under threat of life. Once it was known the fact that the house was less than one minutes walk from my old place, in its self, demonstrates why it was not suitable.

DOCTORS EVIDENCE

24. You wish me to provide a letter from my doctors, as there is more than one, that the property WCC thought was suitable for me was intact not suitable. This is to include:

24.1. Why it was not suitable for someone on the Autistic Spectrum of Conditions

24.2. Why it was not suitable for someone with a PTSD and two C-PTSDs

POLICE EVIDENCE

I need to provide Incident Numbers for the events I reported to the Police showing that where WCC thought it was safe for me to live was in fact not safe. This is to include but not limited to:

25. Each time I reported being a Pedo

26. Every time I was threaten for such a lie

27. When I reported I was a Male Victim of Domestic Abuse and the Police stated for Safeguarding Reasons I and my Abuser needed to live far apart from them. Given that the Council moved my Abuser into a house less than five minutes walk from where I was currently living and also the second offer of housing it shows that the Council, once again, refused to take seriously that I was under any sort of danger

28. I am to contact the only police office, Tom Harris (27719) who was on my side and did everything he could to help

COURT AND SOLICITORS

I am to provide evidence that:

29. As soon as I knew WCC where trying to evict me, as WCC deliberately hide the fact I was going to court from me, I contacted the Court to inform them of the illegal eviction and that WCC purged themselves in order to get the Court Eviction

30. I am to provide the emails I have from a number of Solicitors that they would take the case on Legal Aid, however, could not because of the backlog of cases they had to deal with

31. I am to provide details of the Solicitor I did find to take my case when I was able to pay the initial fee they asked for

31.1.I am to provide evidence that after further investigation this firm confirm that I had a case, however, based on the fact that it would cost me around £20,000 they thought it unfair to take as they did not believe I could afford to pay this amount

SAFEGUARDING AND OFFER OF HOUSING

I am to contact the lady who was a Safeguard Officer with autistic experience. She is to explain that:
32.If she had been working with me six months before she was this whole housing situation would not have happened

33.She is to explain that she bid on houses for me, that whilst not being suitable, was better than living on the street

34.She is to explain that WCC accepted my bids

35.She is to explain that WCC told me/her that I had won a bid and had a house to move into

36.She is to explain that we waited over three weeks for the other people to move out and allow me to move in

37.She is to explain that after this period of time WCC then turned around to her and said that WCC had decided "they didn't want me as a tenant"

38.She is to explain that she has no idea why WCC made me go through this process when they could have said at this start they didn't want me as a Tennant

That is all I can think of after finding out this shock news from you.

39.Given that it appears all that matters is what WCC says, as I was clear from you at the beginning about all of this, I believe it will not matter what evidence I provide, as from the comments you made about what is to stop where I am currently becoming a place where I am attacked for no reason, you will stay with your opinion I deliberately made my self homeless and thus have no duty.
